DISCUSSION HELD RE: COMMENTS ON THE YEAR 2011 – As outgoing Board President Matt Coffland reiterated his feelings that 2011 was a turnaround year for Belmont County. He stated he thinks the board has done a lot of groundwork. He said, “We have planted the crops and I think in 2012 we are going to reap the harvest.” He noted the negotiation of four union contracts in 2011; courthouse employees were given a small increase in 2011; and he hopes things get better. Mr. Coffland stated it has been a pleasure and an honor to serve Belmont County as the President this past year.

Mrs. Favede said she couldn’t agree more and it’s been a tremendous three years. She advised that when she and Matt took office they put their heads together and came up with three things they wanted to accomplish within four years; those being 1) Mt. Victory Waterline Project; 2) Neffs Sewer Project, and 3) and the Mall Road Overpass Project. Mr. Coffland said the Mall Road Overpass Project is moving along “We wish we were a little farther ahead, but we are a lot farther ahead than the way we found it.”

Port Authority Director Larry Merry thanked the board for the tremendous amount of groundwork laid the last couple of years. He also thinks the results of that will be forthcoming here in the next few months and years. He thinks better employment opportunities are coming. He said this board faced tough decisions a couple of years ago that now have helped turn the county around. He thanked the board for making issues such as clean drinking water for Mt. Victory residents and sewage issues a priority and making Belmont County a better place to live.

Mr. Coffland concluded by stating, “Our staff does a fantastic job.”
