Dear Commissioners:

Please let this letter serve as our proposal and contract to provide Home Buyer Counseling Services for Belmont County's Community Housing Improvement Program Grant.

It is our understanding that completion of Home Buyer Counseling classes is a prerequisite to receiving Down Payment and Housing Rehabilitation through Belmont County's CHIP Program. As such, our office will be receiving referrals from Belomar for our class offerings and in turn will refer qualified individuals to Belomar Down Payment and Housing Rehabilitation assistance through your grant.

Potential home buyers will attend either a 6 hour workshop on two consecutive Saturdays or attend 3 hour workshops held two times a week for three weeks. Home buyer Counseling classes will include various topics, including the following:

- How to budget and save for a down payment
- How to find a home and make an offer
- How to apply for financing
- What takes place at closing
- How to establish a post purchase budget
- Why it is so important to maintain a home

In return for these counseling services, the CAC will be paid a lump sum fee of \$300.00 for each successful home buyer who receives assistance through the Belmont County CHIP Program. The funds for said services are to come from a line item in the County's CHIP Grant earmarked for the Home Buyer Counseling. The CAC will invoice Belomar after each individual client loan closing occurs.

The term of this agreement will be for the duration of the CHIP grant program which is August 1, 2001 to May 31, 2003 or until all down payment funds have been exhausted under the CHIP Down Payment Assistance Home Buyers Program.

RESOLVED, That we do find and consider said improvement of sufficient public importance to instruct the County Engineer to make an accurate survey and plat of the same, and furnish an accurate and detailed description of the proposed improvement describing the center line and right of way lines thereof.

Said County Engineer shall also furnish an accurate and detailed description of each tract of land which he believes will be necessary to be taken in the even the proposed improvement be made, together with the name of each owner.

Said County Engineer shall also, at the time of making such survey, set stakes at the termini of each right of way line and at all angles between such termini, and at sufficient other points on the right of way lines so that the bounds of the proposed improvement may be discernible to property owners and other interested persons; and be it further

RESOLVED, That the said County Engineer be and he is hereby directed to make a report in writing to this Board, on or before the 5th day of December, 2001 the date fixed for the final hearing, setting forth the opinion of said County Engineer either for or against said proposed improvement, ² and the width to which said improvement shall be opened, which shall not be less than thirty feet; said report shall be accompanied by said plat and detailed and accurate descriptions, and filed with the County Commissioners, and this case is continued unto said date.

IN THE MATTER OF DISCUSSION HELD
RE: GABE HAYES; NATIONAL ROAD

Mr. Gabe Hayes, Belmont County resident came before the Board to present a summary update of the Corridor Management Plan for the National Road received from the Ohio Department of Natural Resources.

Mr. Hayes presented the Board with the summary book and proceeded to highlight the various chapters and summarized their possible benefit to the county. He stated, "This plan is a suggestion for local implementation. It is a bottom up plan, you could go as high as you choose." Mr. Hayes continued, "The most important thing to remember is to look at this plan in a holistic manner. Look at it through the experience of a tourist, as well as local residents. It is important to think of it as a plan. If you truly want to preserve the history and promote our area, you could set a plan and begin a process. We want jobs as well. There are ways to address them both."

Mr. Hayes encouraged the Board to review the material submitted and contact him with any questions. He continued, "Let me know where you want to go with this. There is over four million dollars that we could possibly use in areas such as cleaning up places along the river and perhaps old mining sites. Also, there are monies earmarked for bike trails as well as preservation of open spaces." Commissioner Thomas informed the media present that Mr. Hayes is a local architect who lives and works in St. Clairsville and is easily contacted for information. He continued, "It is good to have local representation."

Commissioner Probst asked what the Commissioners needed to do to show their support. Mr. Hayes informed the Board that the area towns and villages need to do their part and suggested, "The Commissioners could conduct a study and plan for the unincorporated roads along Route 40. To make this a process and ensure a non-negative impact to the locals living along these routes, such a study should be the first priority." Commissioner Probst questioned if a committee and sub-committee with members from area villages and towns would be a good idea. Mr. Hayes ended his presentation by stating, "There is a tremendous amount of money that could come into our county. Belmont County is unique in that it has two National Scenic Byways, Bridgeport is a hub that should be taken advantage of. There are many developable sites in the county. Within five years, we'll start seeing the benefits of this program."

Commissioner Thomas stated that along with forming a committee and sub-committee, perhaps the Board could assist in the Blaine Bridge project, possibly in the areas of traffic patterns and such." Mr. Hayes stated Glenn Harper of the Ohio Historical Society will be sending the county more pamphlets that may be circulated as the Board deems necessary.

Commissioner Thomas thanked Mr. Hayes for the summary and stated, "We do sit here in Belmont County with great potential due to Route 7 and Route 40 going through. Again, Gabe, we appreciate your work on behalf of the residents of the County - we thank you."
